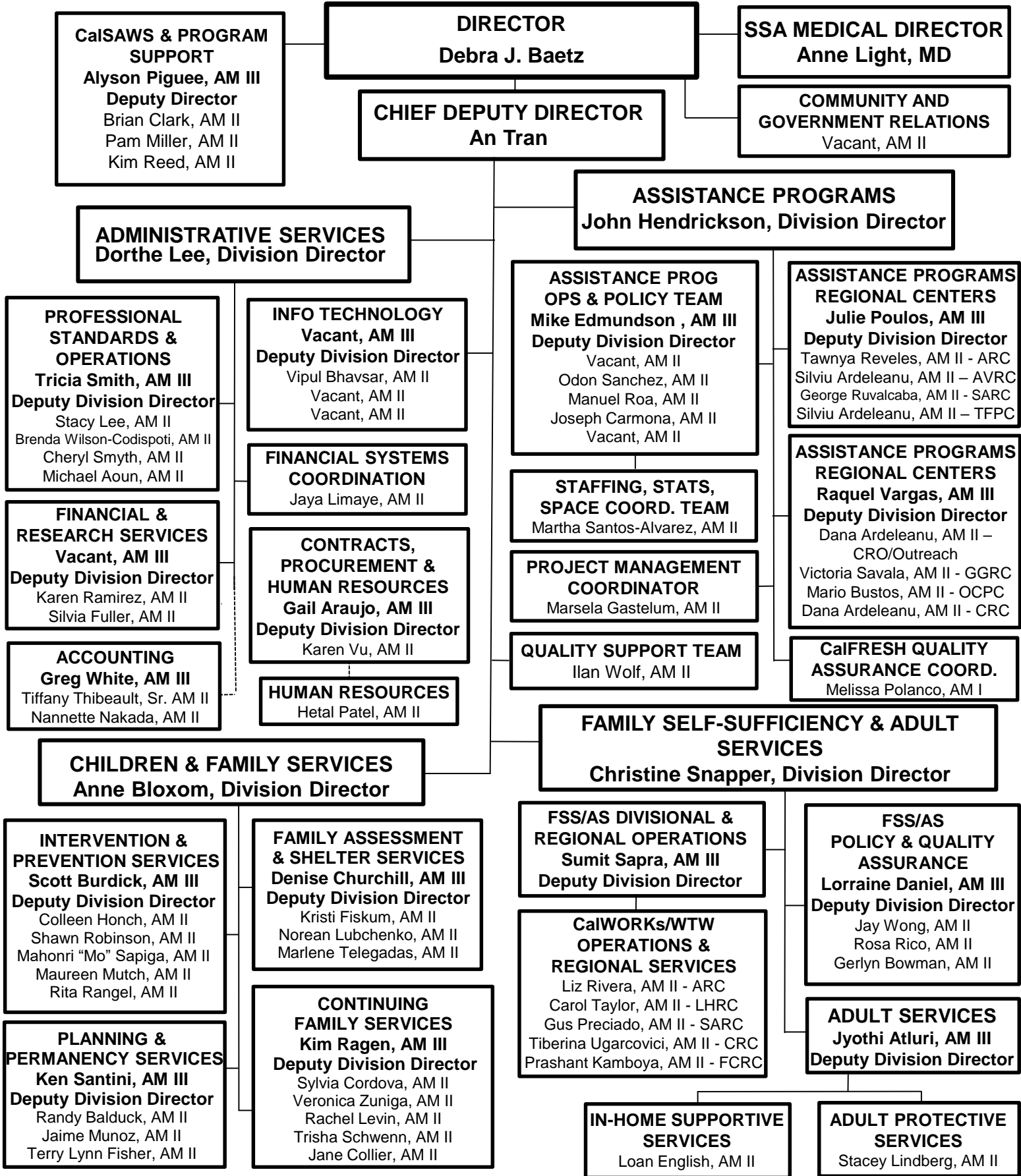
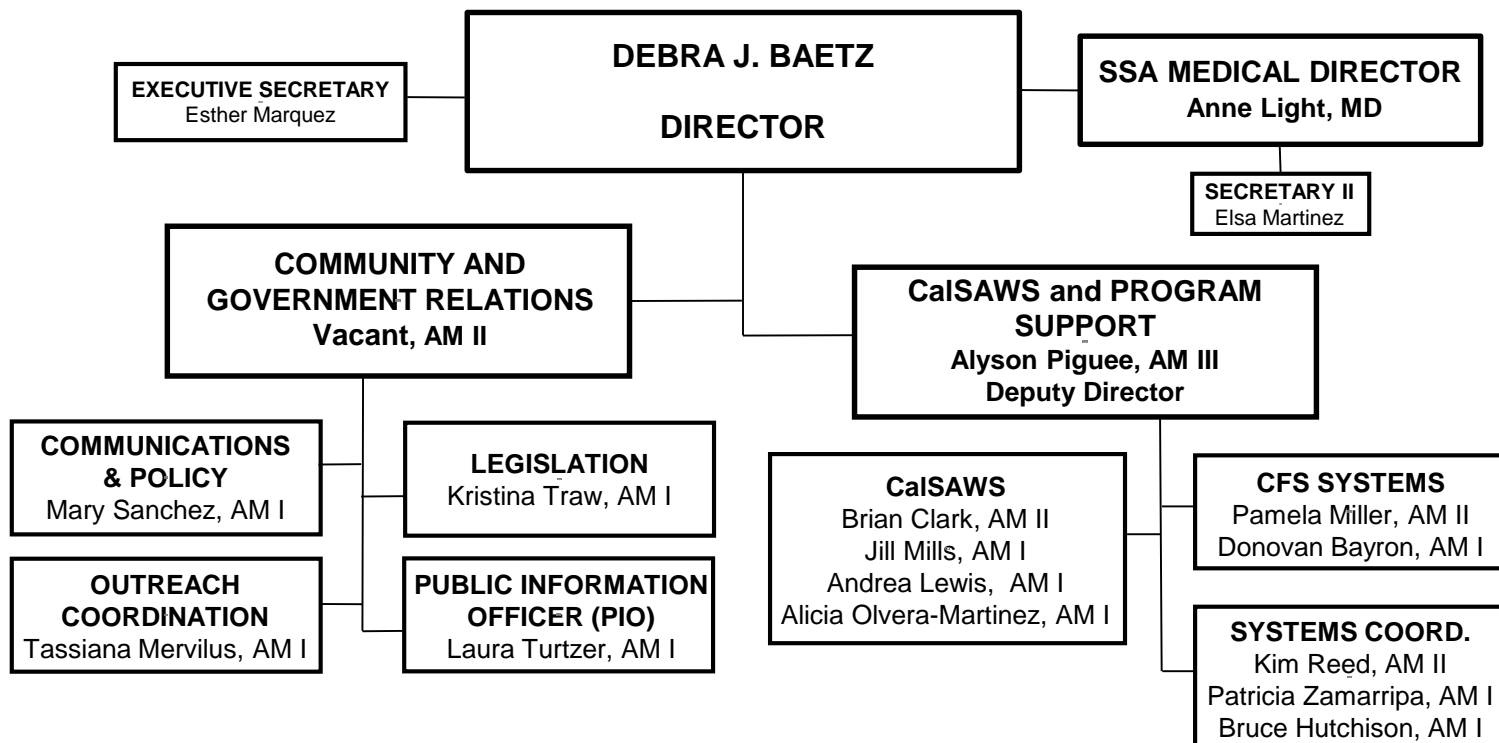


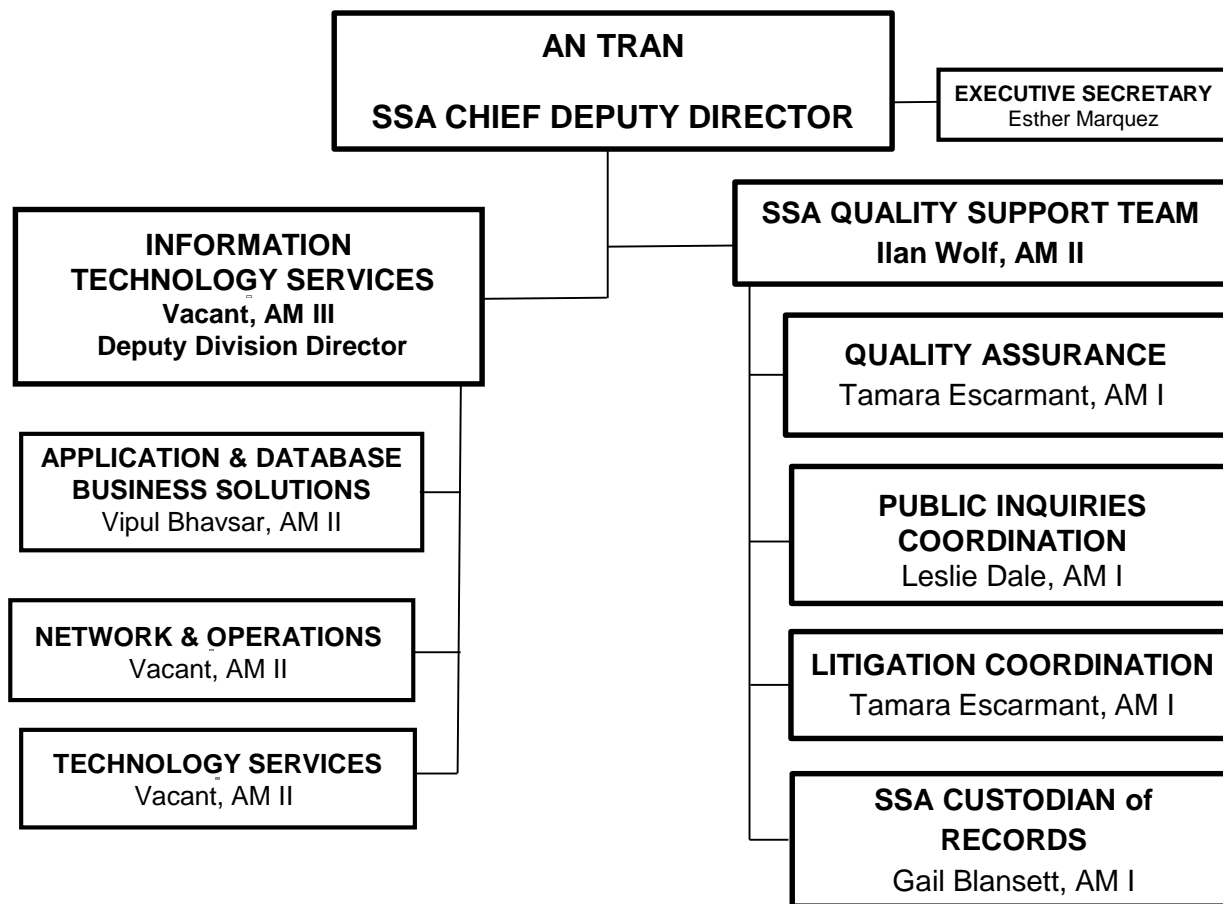
Organizational Chart



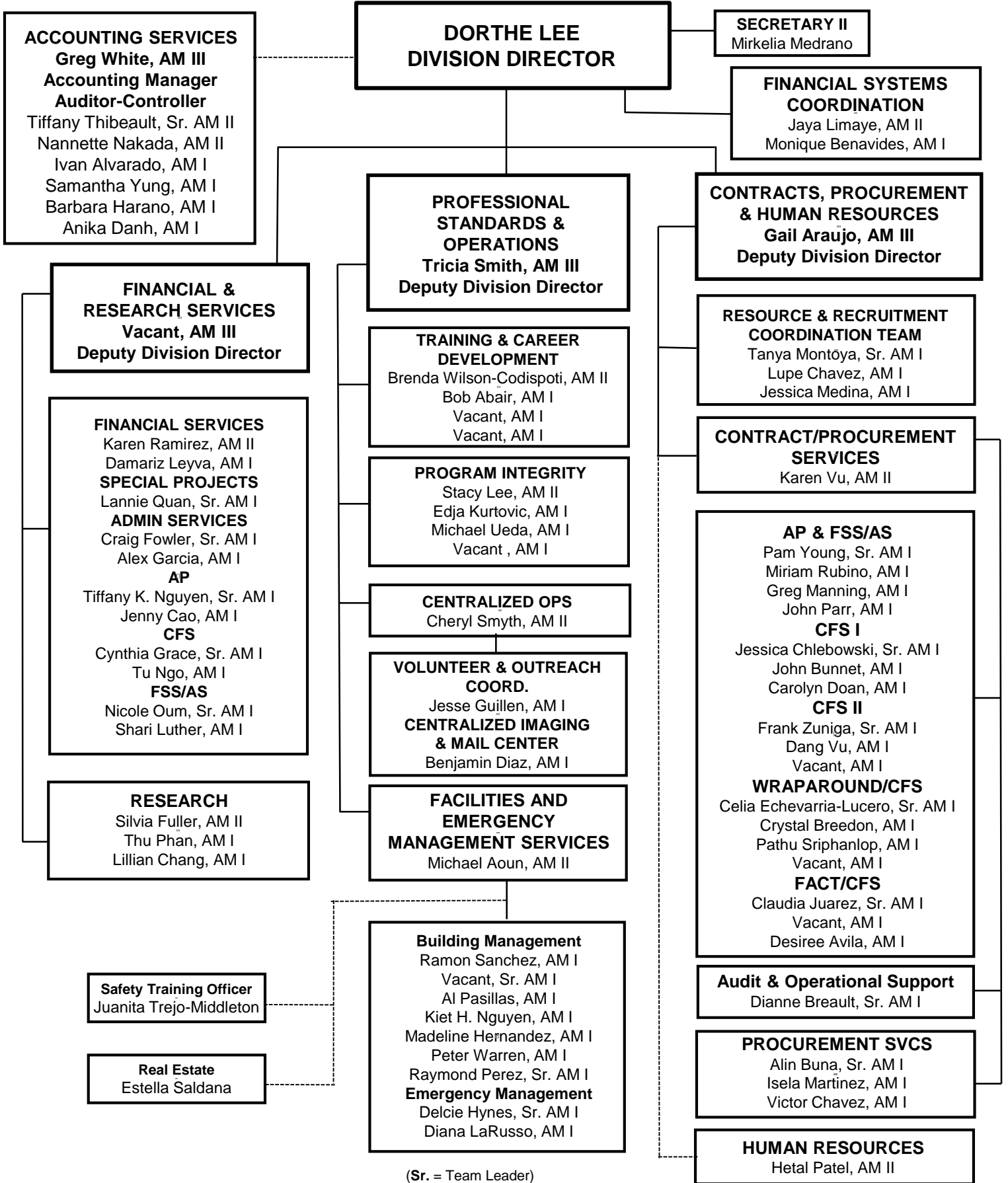

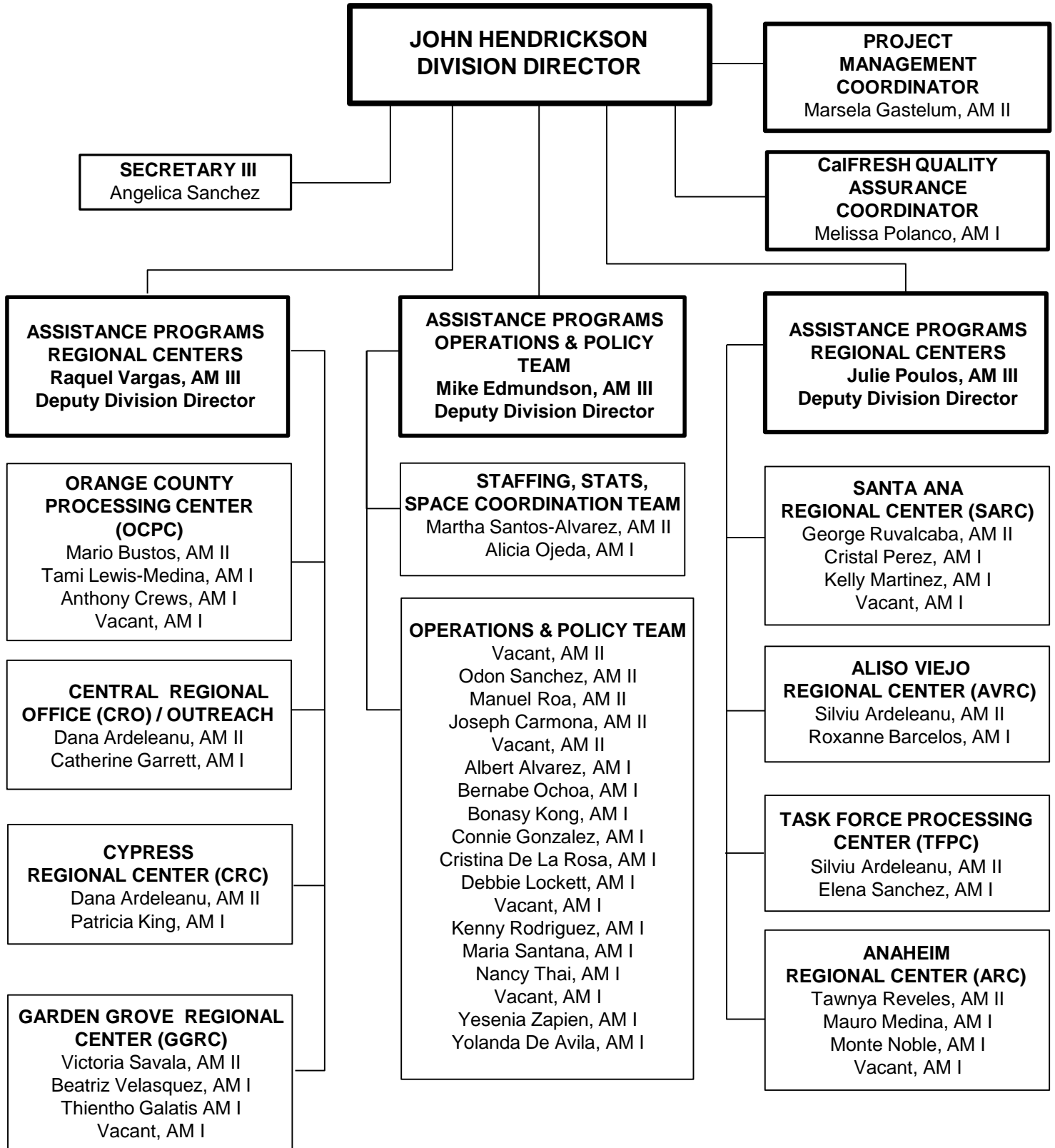

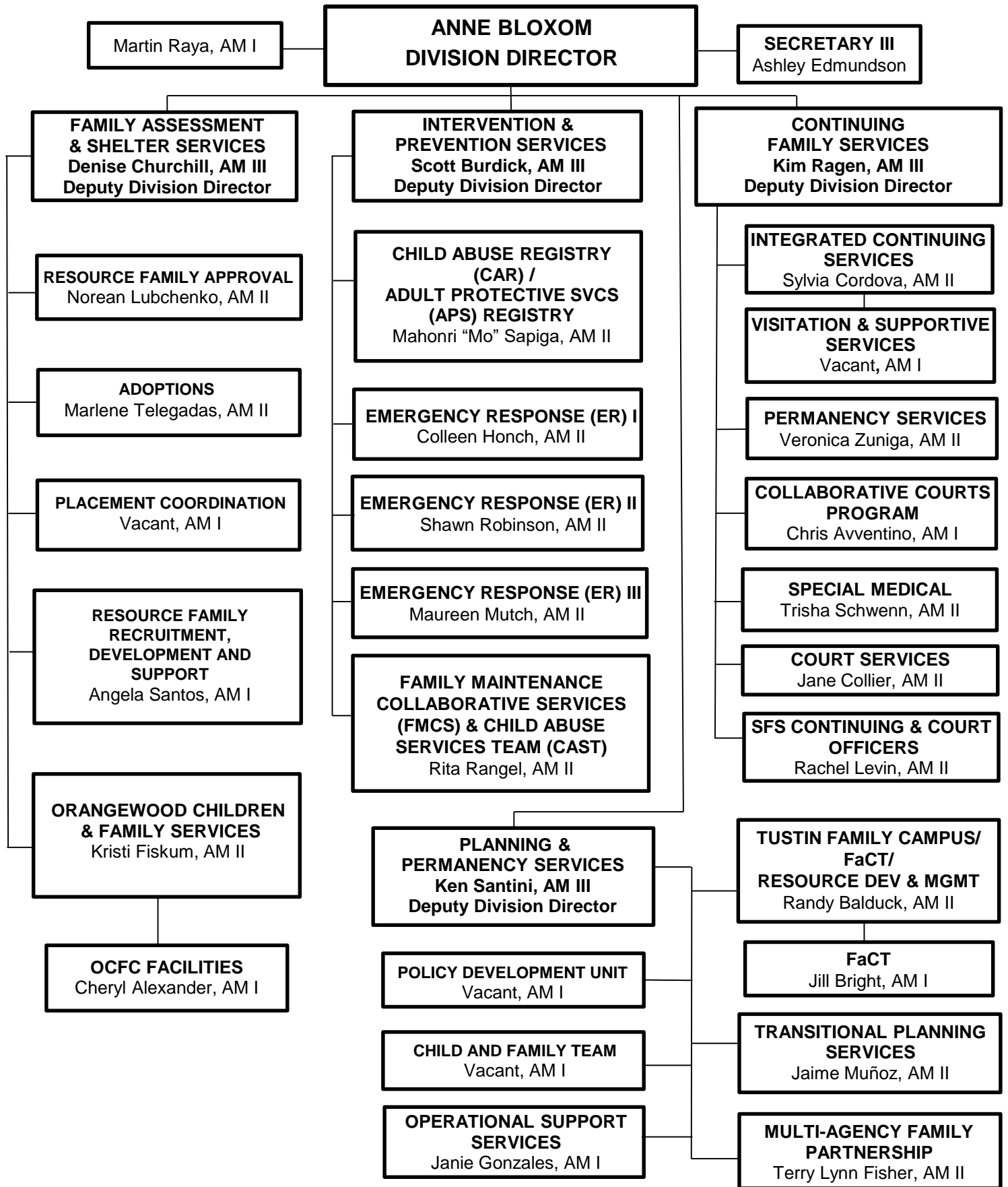
