3. OCCP Bylaws – Laura Turtzer

The Board of Supervisors recently issued a new policy for Board and Commission Bylaw components, as a result the Orange County Children's Partnership (OCCP) will need to establish formal bylaws. The committee briefly reviewed and discussed OCCP's unofficial bylaws drafted in 2017. The initial draft was never finalized and presented to the Board of Supervisors for official approval. OCCP committee agreed to create a bylaw adhoc committee to discuss OCCP's mission statement and goals. The committee will then bring back a redline version to OCCP for initial discussion in February with the goal of formal adoption in March. A redline version to be distributed.

4. 2022 OCCP Areas of Focus/Goal

a) Legislative Updates – Kristina Traw/Debra Baetz

The second year of California's legislative session began on January 3, 2022, and the deadline to introduce new bills is February 18, 2022. The deadline for bills from last year to move out of their house of origin is January 31, 2022. If bills do not move, they are considered "dead" and cannot move forward this year. The federal Build Back Better bill has encountered issues and does not currently have any traction to move forward.

Recent policy changes in the governor's budget is the expansion of Medi-Cal. Medi-Cal initially had a restricted category based on status as a resident. Beginning January 2024, the remaining uncovered population between the ages of 27 and 49 will now be eligible for full scope Medi-Cal regardless of status, as long as the individual meets eligibility requirements.
