DEFINITIONS

Abuse

Physical abuse, neglect, financial abuse, abandonment, isolation, abduction, or other treatment resulting in physical harm, pain, or mental suffering or the deprivation by a care custodian of goods or services that are necessary to avoid physical harm or mental suffering.

Adult Protective Services

Investigations, needs assessments, remedial, and preventive social work activities; the necessary tangible resources such as food, transportation, emergency shelter, and in-home protective care; the use of multidisciplinary teams; and a system in which reporting of abuse can occur 24-hour basis.

Dependent Adult

Any person residing in this state, between the ages of 18 and 59 years, who has physical or mental limitations that restrict their ability to carry out normal activities or to protect their rights including, but not limited to, persons who have physical or developmental disabilities or whose physical or mental abilities have diminished because of age or any person between the ages of 18 and 59 who is admitted as an inpatient to a 24-hour health facility.

Elder

Any person residing in California who is 60 years of age or older.

Immediate life threat

Elder or dependent adult is presently at risk of serious physical harm, injury, or death through either their own action(s), or inaction, or because of the action or inaction of another person.

Imminent danger

A substantial probability that an elder or dependent adult is in imminent or immediate risk of death or serious physical harm through either their own action(s) or inaction, or as a result of the actions or inactions of another person.

In-person

Face-to-face meetings between the APS worker and the individual reported to be in need of, or who has been determined to be in need of APS.

Investigation

Activity undertaken to determine the validity of a report of elder or dependent abuse.

Jurisdiction

APS shall investigate all reports of known or suspected abuse or neglect of an elder or dependent adult residing in their county, except those that occur in or under the supervision of a long-term care facility, state hospital, state developmental center, or other county or state.

Local Law Enforcement Agency

A city police or county sheriff's department, or a county probation department, except persons who do not work directly with elders or dependent adults as part of their official duties, including members of support staff and maintenance staff

Neglect

The negligent failure of any person having the care or custody of an elder or dependent adult to exercise that degree of care that a reasonable person in a like position would exercise **or** the negligent failure of the person themselves to exercise that degree of care that a reasonable person in a like situation would exercise.

RESPONSE AND INVESTIGATION

- 1) When a report of known or suspected abuse or neglect of an elder or dependent adult is determined to be within the jurisdiction of the adult protective services agency, documentation of an allegation of abuse or neglect shall be made on the Report of Suspected Dependent Adult/Elder Abuse (SOC 341) provided by the Department. The adult protective services worker shall:
 - a) If there is a report of an immediate life threat, imminent danger, or a crisis in an existing case, attempt to immediately make in-person contact with the elder or dependent adult for purposes of intake or intervention.
 - i) Provide an immediate in-person response when the local law enforcement agency requests it
 - b) Respond to all other reports of danger of abuse or neglect as soon as necessary to protect the elder or dependent adult, but in no case will the response be more than 10 calendar days from the initial report
 - c) Investigate all incidents of known or suspected abuse or neglect of an elder or dependent adult when a violation of the Penal Code has been alleged

- 2) An in-person response is not required under the following circumstances:
 - a) Adult protective services worker has made repeated attempts to locate the elder or dependent adult or their family, but has been unsuccessful.
 - b) Elder or dependent adult has moved out-of-state or out-of-county. The adult protective services worker must report the alleged abuse or neglect to the appropriate county or out-of state adult protective services agency.
 - c) Elder or dependent adult is deceased and there is no indication that another elder or dependent adult is at risk.
 - d) The report of known or suspected abuse or neglect is of a past occurrence without new allegations of abuse or neglect and there are no present risks to the elder or dependent adult. The adult protective services worker may confirm that there are no present risks to the elder or dependent adult through contacts with other agencies.
 - i) An immediate or 10-day in-person response is not required when the county, based upon an evaluation of risk determines, and documents, that the elder or dependent adult is not in imminent danger and that an immediate or 10-day in-person response is not necessary to protect the health or safety of the elder or dependent adult
 - ii) Until criteria and standards are developed to implement paragraph 2.a.i (above), the county's evaluation shall include and document all of the following:
 - (1) Factors that led to the county's decision that an in-person response was not required
 - (2) Level of risk to the elder or dependent adult, including collateral contacts
 - (3) A review of previous referrals and other relevant information as indicated
 - (4) Need for intervention at the time
 - (5) Need for protective services
- 3) When the adult protective services worker does not provide an in-person response, the following information shall be documented in the case record.
 - a) The adult protective services worker shall document in the case record all facts justifying not making an in-person response.
 - b) The adult protective services supervisor must document in the case file approval of not making an in-person response.
- 4) In investigating a report of alleged abuse or neglect, the adult protective services worker shall:
 - a) Attempt to obtain the consent of the elder or dependent adult to enter their residence to meet privately without the presence of the person's caretaker, attendant, family, or household members.
 - b) If the elder or dependent adult does not give consent for a private meeting at their residence, the adult protective services worker shall:
 - i) Make attempts to meet with the elder or dependent adult privately at some other convenient place, **or**

- ii) Make attempts to meet with the elder or dependent adult in the presence of a person of the elder's or dependent adult's choice.
- 5) The adult protective services worker shall request the assistance of law enforcement in attempting to enter the elder's or dependent adult's residence if:
 - a) The adult protective services worker has been denied access to the elder's or dependent adult's residence by someone other than the elder or dependent adult, and
 - b) If the adult protective services worker has reason to believe the elder or dependent adult is subject to abuse or neglect
