DMV Identification Cards—Reduced Fee

Purpose	To provide guidelines when assisting clients to obtain a Department of Motor Vehicles (DMV) Identification (ID) card at a reduced fee.
Approved	This policy was approved by Mike Ryan, Director of CFS, on March 13, 2008. <i>Signature on file.</i>
Background	<p>Eligible clients may obtain a DMV ID card at a reduced fee.</p> <p>SB 1098 (Chapter 212 of the Statutes of 2004) allows persons whose income level meets the eligibility requirements of benefit/services programs subsequent to Welfare and Institutions Code Section (WIC) Division 9 to obtain a DMV ID card at a fee of \$6.00*, reduced from \$21.00. The agency providing the benefits/services must verify the person's eligibility by completing the mandatory DMV form DL 937—Verification for Reduced Fee Identification Card</p> <p>Note: The reduced fee is tied to the California Price Index (CPI), and is, therefore, subject to change per the CPI.</p>

POLICY

Eligibility	<p>All Children and Family Services (CFS) clients also participating in an open California Work Opportunity and Responsibility for Kids (CalWORKs) case are eligible to apply for a reduced fee DMV ID card. Eligible clients include the following:</p> <ul style="list-style-type: none">• Domestic Abuse Services Unit (DASU)• AFDC-foster care recipients• Kin-GAP recipients
Client Notification Process	<p>CFS staff will complete the following activities to ensure that eligible clients are informed of the availability of a reduced fee DMV ID card:</p> <ul style="list-style-type: none">• The assigned Eligibility Technician (ET) will provide youth in foster care/Kin-GAP with a copy of the SSA flyer “Reduced Fee for California Department of Motor Vehicles Identification Card” when they turn age 16 and annually until the case is discontinued• If the youth requests a reduced fee DMV ID card, the ET will send the caregiver a copy of a completed reduced fee application
Certification Process	<p>The following policy applies when a client requests certification of eligibility for a reduced DMV ID card:</p> <p>A. All CFS clients who meet the above eligibility requirements are to be referred by the ET to the DMV with a completed DL 937 form.</p> <p>B. The assigned ET will complete the DL 937 form as follows:</p> <ol style="list-style-type: none">1. Do not give a blank form to the client.2. Do not alter the DL 937 in any manner.3. Fill out the form completely and legibly.4. All signatures must be original.

5. Do not make any corrections or write-overs on the form. If an error is made in completing the form, destroy the form and complete a new one.
 6. Assist the client to fill out his or her portion of the form.
 7. Instruct the client to submit the completed form to the DMV within 60 days of the ET's signature.
